Expertise in wood science, building materials, wood preservation, decay/insects, wood-based composites, wood poles, flooring, wood species identification, ISO/IEC 17025, and OSHA standards regarding wood scaffolds & ladders, and wooden windows/fenestration.

Time Charges

For all legal issues related to consultation activities, such as reviewing documents and depositions, fieldwork, literature review, consultation with the client or other experts, report writing, travel, etc., the hourly fee is \$400. Deposition and trial testimony is \$625/hour with a \$5,000 minimum. All rates for all services are increased by 50% for work that is required to be conducted outside of regular business hours, weekends, federal holidays, and any work requested to be expedited.

The \$5,000 deposit for testimony fees is due immediately upon either asking me to hold tentative date(s) for my testimony, informing me of definitive date(s) for my testimony, or my receipt of a subpoena from any party in the pending matter. This fee is non-refundable within two weeks of the start date of my testimony. This fee shall not serve as a credit for any future work outside of the testimony date(s) in the initial notification. If this minimum fee is exceeded, the balance will be invoiced to the client after the testimony has concluded. After 60 days from my invoice date for testimony fees, the retaining attorney assumes responsibility for payment in full of my testimony fees.

Expenses

All travel time is calculated from portal to portal. Travel time begins when I leave my office and ends when I return to my office. All expenses are billed at cost, and all major expenses, except required travel, are pre-approved by the client. All travel-related expenses are to be reimbursed at cost. Hourly testimony expenses are also charged as described above and apply to any time spent waiting to provide testimony. Starting two weeks from my scheduled appearance for testimony and/or consultation, if my appearance is deemed canceled or otherwise postponed, then the client agrees to pay half of my normal hourly rates for the total time that I reserved to be present and any out of pocket travel expenses that may have already been incurred.

Retainer

A non-refundable \$5,000 retainer is required for all legal work to initiate an engagement, and no use or otherwise disclosure of my name is allowed until the retainer is received. To retain me, please

A \$5,000 retainer is owed to me if I am designated as an expert, regardless of whether I am called upon to provide testimony, material review, or any work product.

Invoicing

An invoice is submitted monthly that documents the accumulated time and expenses for the engagement as well as any credit remaining from the retainer. If the retainer has been depleted, payment is due in full upon receipt of the invoice. Any invoices unpaid within 30 days of the invoice date are considered past due and subject to an interest charge of 1.5% per month. Work will stop if any invoice is unpaid after 60 days and will resume once all invoices have been paid in full.
